NORTH CENTRAL MICHIGAN COLLEGE BOARD OF TRUSTEES SPECIAL MEETING – Library Conference Rooms 1 & 2 Thursday, November 16, 2023 (4:00 p.m.)

1. CALL TO ORDER

Chairman Rasmussen called the meeting to order at 4:00 p.m.

4. APPOINTMENT OF BOARD MEMBER

Chairman Rasmussen noted as many are aware, Trustee Jennifer Shorter tendered her resignation from the Board of Trustees on October 26, 2023, creating a vacancy.

Pursuant to the Community College Act of 1966, Act 331, Section 389.158, the remaining members of the Board, by majority vote, shall fill the vacancy immediately. This person so appointed shall hold office until the next regular community college election held for the election of members to the board of trustees.

It was moved by Chairman Rasmussen that the board appoint Keith Pretty to fill the vacancy on the Board, and he provided the following background:

Keith Pretty joined Northwood University as President and CEO in 2006 and retired as President Emeritus in 2019. He came to Northwood from Walsh College where he served as President for seven years. Prior to Walsh, he was Vice President for external affairs and General Counsel at Western Michigan University and President and CEO of the Western Michigan University Foundation. Prior to his service at WMU, Pretty held executive roles in the private sector with the Standard Oil Company. Pretty earned a Bachelor of Science degree in Education from Western Michigan University and a juris doctor degree from the Thomas M. Cooley Law School. He is the recipient of many awards and commendations and has served on numerous boards and commissions in both the public and private sectors. Pretty is married to Gretchen and they have four adult children and reside in Harbor Springs, Michigan.

Erick Haight, Professor of Psychology and Humanities at North Central Michigan College, inquired as to how many individuals are in the current pool of candidates for consideration of the Trustee position. Chairman Rasmussen estimated the pool consists of 15-20 candidates.
